

# **GVR CAMERA CLUB PRIVACY POLICY**

Your privacy is important to us at the GVR Camera Club. The GVR Camera Club is committed to protecting the privacy and confidentiality of its members' personal information

We are not in the business of selling personal information. Information is required in order for our website to function properly and for the experience to be as efficient for you, the user, as possible.

We only collect personal information that is relevant to the purpose of our website. This information allows us to provide you with a customized and efficient experience.

We exercise all reasonable and customary practices to safeguard members' personal data from unauthorized access by entities not directly engaged in Camera Club operations.

This privacy notice discloses the privacy practices for the GVR Camera Club. This privacy notice applies solely to information collected by this website.

## **Collecting, Holding and Using Personal Information**

The GVR CAMERA CLUB may collect, hold and use members' personal information for the following purposes:

1. Identifying you and ensuring that the collected information is correct.
2. Contacting you in regard to club activities and events.
3. Advising you of photographic events, sales and competitions held or sponsored by other photographic clubs, retailers, artists, or institutions.
4. Tracking your image submissions for various inter-and intra-club competitions that may be held during the year.
5. Tracking your photographic standing within the club.
6. Enabling your member account on the GVR Camera Club website and permitting email communication to you via the website from other members or from the club members authorized to do so.
7. Listing your name, and possibly your city of residence on the club's website, including the use of your name in captions of your images.
8. Listing your name, and possibly your city of residence, in promoting material for the GVR Camera Club, including adding your name to captions of images that are promoted by the club.
9. Creating name tags for use at club events.
10. Maintaining club records of membership dues.

"Personal information" includes, at a minimum, your name, address, telephone number, email address, and GVR membership number. Depending on the nature of the club activities in which you participate, additional personal information may be collected as necessary.

## **Consent**

Your knowledge and consent to the GVR Camera Club's collection and use of your personal information is important. GVR Camera Club relies on your actions as indications of your consent of the club's existing and future personal information collection practices:

- Your voluntary provisions of personal information directly to the club's Board of Directors.
- Your consent solicited by a member of the club's Board of Directors or designate for a specific purpose.
- Your receipt of this privacy policy until you notify the GVR Camera Club Board of Directors of a withdrawal of you consent.
- Your consent given through an authorized representative such as a legal guardian, agent, or solicitor.

You may withdraw your consent to the club's holding of personal information at any time. Your withdrawal of consent will limit the GVR Camera Club Board of Directors ability to provide you with information surrounding club activities.

## **Third Parties**

The GVR Camera Club Board of Directors may disclose your personal information to individuals, businesses, corporations, and other photographic organizations or artistic entities when the board of directors believes that such disclosure is in your best interest as a member of the club.

The Board of Directors will only disclose that information which is sufficient for the purpose it is required. For example, we may disclose you mailing address to a photographic association or similar group in order for you to receive information or material directly from them.

The Board of Directors will not knowingly disclose personal information to third parties for commercial purposes. In particular, the board will not disclose personal information for the purpose of telemarketing, unsolicited email, or advertising mailings, or similar business activity.

We do not receive data from third parties, only from our membership.

## **Right of Access**

You are entitled to access, with reasonable notice, your personal information maintained by GVR Camera Club. You may verify this personal information and request that any inaccurate information be corrected. An access request may be made to any member of the GVR Camera Club Board of Directors, orally, or in writing.

## **Limits of Retention**

The GVR CAMERA CLUB will only retain your personal information as long as it is necessary, at most for three calendar years following the end of the GVR Camera Club year (typically in December) if your membership in the club is not renewed. At the end of that period all copies of your personal information will be destroyed or deleted.
